FLAMES LEVEL **CAUTIN BLOCK IN**

Firemen Struggle on Cold Day of Winter to Save Stores and Apartments-Loss Over \$50,000

Fire believed to have started in the basement of the A. & P. store, located in the Cautin block at Elizabeth town, Saturday night, razed the block, largest in that village, and wiped out two grocery stores, barber shop, one clothing store and haberdashery, a vacant store, photographer's studio, a beauty parlor and an apartment, with a loss estimated at between \$50,000

Discovered at 6:10 p. m., the flames quickly spread the entire length of the block. The volunteer lire department of that town battled valiantly as well as the department from Westport which partment from westport which was summoned by telephone, but a light wind fanned the blaze and in two and a half hours all that remained of the block was a mass of smouldering ruins.

Besides the A. & P. store destroyed, was also the clothing store and haberdashery conducted by Aaron Cautin, owner of the block and brother of Lester Cautics (1) tin of this village; a grocery operated by William Denton, a barber shop operated by George Cautin, the Underwood photo studio, an apartment occupied by Mr. and Mrs. William Denton located on the ton floor and a bounty norder the top floor and a beauty parlor

on the same floor.

Struggling against overwhelming odds with the thermometer well below zero, firemen in ice encrusted clothes were powerless to stop the rush of flames. Several of the fighters are reported to have suffered frostbites although none seriously.

FORD SALES LEAD FOR PAST FIVE YEARS

Manufacture of the Model T was discontinued in the Model I was discontinued in May, 1927, Ford being out of the market until December of that year when the Model A was an-nounced. Ford again was out of nounced. Ford again was out of the market for the first five months of 1932 until volume deliveries of the new Fords began last June.

SUGGESTS FOOD FOR **COLD WINTER WEATHER**

Cold days suggest warm, rich spicy foods and one of the best dishes, says the New York state college of home economics

Squash onion, three slices of bacon, two cups of canned tomatoes, green pepper, salt and pepper. Combine them with squash to make a main dish fit for any table. The bacon should be cut in small pieces and fried, then the onion, sliced thin, added to it and cooked until yellow. The squash, cut in thin crosswise slices is added next, together with the pepper cut in small pieces, the tomato, and the desired amount of salt and pepper. The whole mixture should be covered and allowed to cook slow-ly until it is tender.

Another hot dish for cold days is eggplant caserole. Slice and pare the eggplant, and place the slices in a buttered baking dish, add salt and bits of butter and sprinkle generously with grated Parmesan cheese. This is cov-Parmesan cheese. This is covered with sliced tomatoes and enough salt, pepper, and butter for seasoning. It should be baked in a moderate oven 350 to 400 degrees Fahrenheit until the eggplant is tender, or from thirty to forty-five minutes.

BUILDING **ROAD UP SIDE** OF BEAR MT.

1100 Men Working on Palisades Park Projec*

A broad motor highway up one side of Bear Mountain to its peak and down the other side is being constructed this winter by men selected from the ranks of the un-employed in New York city.

Each morning before dawn, 1100 men assemble in the 42nd Street ferryhouse, are carried across the Hudson and taken by special train from Weehawken to Bear Mountain 44 miles away, in order that they might be given jobs. Each evening they return by the same route after having put in a full 8-hour day building this special road and working on other extensive park improvements.

When completed, probably next

spring, this road for the first time will permit motorists to ascend to the top of one of New York's most picturesque mountains and obtain a magnificent view of the Hudson Valley along its most beautiful stretch.

The mountain is located in Palisades Interstate Park, where hundreds of thousands of metropolitan pleasure seekers, campers and hikers visit each summer. Trails lead to its summit, but compara-tively few brave the fatigue of its four-mile ascent to reach this eminence and enjoy this vista. For memer and enjoy this vista. Toy years it has been proposed that a Memorial Highway in honor of the late George W. Perkins be built up the mountain, but funds were lacking.
