Here are some tips on avoiding sunburn

Children's World Learning Centers, in conjunction with the American Cancer Society, gives the following tips to help families have safe fun in the sun this summer by avoiding overexposure of sunlight — a severe sunburn before the age of 18 can double the risk of skin cancer.

Protect babies under six months of age from any prolonged exposure to the sun. Talk to your physician about the use of sunscreens on babies.

Children with non-white skin also get sunburned, although it's harder to detect because it's more difficult to see the pink color of the burn.

Suggest that children participate in indoor activities, like reading, during the hours of greatest sun exposure, which is between 10 a.m. and 3 p.m.

Have your children wear a long-sleeved T-shirt and hat whenever they are going to be outside for 10 minutes or longer between the hours of 10 a.m. and 3 p.m.

Adults also should wear protective clothing and sunscreen to avoid over exposure to sunlight.

Q&A: St. Charles options include one-way street

A. "We have a number of options," said Chuck Tokarski, director of traffic planning and programming for the DuPage County Division of Transportation. The options are variations on two major themes: either turning St. Charles Road into a cul-de-sac or making it a one-way street for westbound traffic only. Although county highway officials are leaning toward the cul-de-sac option, nothing has been ruled out because the project is still in the design stages, Tokarski said. That process includes determining how other streets to the west would be

affected by turning St. Charles Road into a cul de sac at five corners. But at this point, turning St. Charles Road into a cul de sac appears to be the safest option, he added. Making St. Charles Road one-way raises several questions. "How far do you do one-way?" Tokarski asked. "A long distance would be a pretty significant inconvenience to people living on St. Charles; they could only go west." Making St. Charles Road one-way for a short distance might cause some motorists to go eastbound on St. Charles either because of ignorance or of indifference to the one-way street designation. County officials still have to discuss the plan with Glen Ellyn village officials.
